## **Holder House Guest**

### **Covid-19 Protocol**

Spring/Summer 2021

At Threefold we have been doing everything we can to safely and clearly navigate what it means to live in community housing during a global pandemic, and we will continue to do so. We would love to welcome you to Holder House as a guest and ask that you please follow these guidelines:

#### **Supporting Institution:**

All Holder House guests are specifically invited by a Threefold Community Institution, which is responsible for your presence here on campus. Your supporting institution is also standing behind these guidelines, and holding you accountable for them. If these agreements are not upheld, we will inform you of your need to find other housing.

#### **Covid-19 Symptoms/Exposure:**

Holder House is a community living environment which is not fully equipped to support quarantine or isolation in the event of Covid-19 symptoms or exposure. If you have any Covid-19 symptoms or exposure please self-isolate immediately and obtain a Covid-19 test. If the test is positive, we ask you to please inform us immediately and continue to self-isolate – and we strongly recommend finding other accommodations as Holder House is not equipped for long-term isolation. There is a list of local hotels on the Threefold webpage if you need other accommodations.

#### **State Guidelines/County Protocols:**

#### **Testing Before Arrival:**

Regardless of vaccination status, all Holder House guests are required to provide proof of a negative PCR test result before arrival, and within 72 hours. Please email your test results to [holderhouse@threefold.org](mailto:holderhouse@threefold.org).

### **Masks and Distancing in Holder House:**

Holder House accommodates more than 40 people sharing a space simultaneously, therefore **everyone is required to wear a mask at all times whenever outside of their room,** regardless of vaccination status – including in kitchens, hallways, lobbies, and laundry room (bathrooms when possible).

Kitchens are limited to a maximum of 8 people at a time. Once you have prepared your food in the kitchen, all guests are asked to eat in their rooms or outside. Please do not eat in the kitchen and only use it for food preparation.

Holder House has been divided into sections based on different programs and guest groups with separate quarters, bathrooms, kitchens and entrances. **Please only use the section assigned to you, do not enter other kitchens or use other entrances/quarters.**

### **No Visitors in Holder House:**

Holder House is not open to visitors, only registered guests and residents. This applies to all Holder House spaces (rooms, kitchens, etc.).

### **Holder House Guest Covid-19 Protocol Agreement:**
